

Climate Emergency Declaration

Background

Climate change is having, and will continue to have, significant effects on the environment, society, and economy. The scientific consensus is clear that climate change is a real threat and requires urgent action from everyone to protect all life on the planet.

We acknowledge that human behaviours, pollution, and consumption patterns have both immediate and future impacts on the climate and environment, and that we have a role to play to mitigate and manage these impacts on our community.

By declaring a Climate Emergency, we acknowledge the dangers of inaction and the risks of too little action. This Climate Emergency Declaration confirms SureGreen recognition of this science, and our commitment to mitigate the risks that climate change pose for the social, economic, and environmental prosperity of the planet.

Our Climate Emergency Declaration

The international scientific consensus is that climate change is occurring, and that it is driven by human activities having a profound impact on the concentration of greenhouse gas emissions. We recognise that:

- a) the business sector is the primary source of our planetary greenhouse gas emissions; and
- b) the report of the Inter-governmental Panel on Climate Change (IPCC), Special Report: Global Warming of 1.5°C, indicates that we are facing a climate emergency, and as a result, meaningful action on climate change is urgent; and
- c) this IPCC report has found that the world is not on track to limit global warming to less than 1.5°C; and
- d) extreme weather events have devastated and will continue to devastate large parts of Australia and radically impact food production, water availability, public health, infrastructure, the community, and the financial system; and
- e) it is clear that there is a Climate Emergency that requires immediate and radical action by all businesses, including ours; and
- f) the situation is urgent, and we must act now.

While our climate emergency declaration is largely symbolic, the actions behind it are not and we will be using this declaration as a catalyst to create change within our own organisation and with our stakeholders.

- commit to becoming a Climate Clever and Nature Positive organisation
- equip our staff to understand the complexities of climate change and develop their capacity to contribute to shaping a low-carbon future
- forge partnerships with those seeking to build a climate smart, low carbon, and nature positive future
- encourage our clients and suppliers to evaluate their business challenges and opportunities related to
 greenhouse gas emissions, as well as climate risks related to their business operations, products, and services
- mitigate risks, address impacts on natural capital, and identify business opportunities
- wherever we operate make a safer world where people and nature thrive
- identify activities that have the potential to both reduce impacts on people and the planet and improve company performance
- set initial targets for nature and carbon and define a set of actions and integrate them into a broader portfolio of climate initiatives
- provide a framework for corporate carbon and nature positive efforts
- develop and invest in the infrastructure data, skills, and opportunities that would help inform company actions
- implement natural-capital preservation, management and enhancement protocols and map and document our progress
